The Nationals this week moved amendments to the Water Act and Basin Act to address concerns in basin communities about water availability and to give certainty to farm with confidence.

What does it mean?

- Removing the 450 gigalitres as it will cause regional economic harm
- Legislating to stop buybacks
- Enabling new projects and flexibility to offset water
- Ensuring no further water recovery is proposed as part of the Basin Plan review

Basin communities have been crying out for reform to the Basin Plan. Victorian farmers, their New South Wales neighbours and communities right along the Murray have paid the price for nearly a decade because of Labor Party factionalism, and it is the state of Victoria that has done the heavy lifting for the entire Plan.

Enough is enough - it is clear we need to renew the science of the plan. We can do more with less for regional communities and achieve good environmental outcomes. And the Nationals have listened with these critical amendments to the Basin Plan which are now National Party policy.

operations through Regional Forest Agreements.

It was a great day for Australian foresters when a government report recently tabled in the Senate recommended changes to the Regional Forest Agreements framework to give operational certainty that the native forest industry has been crying out for. This follows a controversial ruling of Justice Mortimer which undermined two decades of environmental oversight of forestry

The Senate Environment and Communications Legislation Committee report follows the committee's inquiry on my private Senator's bill – its recommendations vindicate the reasons for my bill and the need for urgent action following the ambiguity created by Justice Mortimer's ruling in the original case against VicForests by Friends of Leadbeater's Possum.

Australia's forestry industries abide by the most stringent environmental standards, set by the Commonwealth and agreed to with the states that have Regional Forest

Agreements. Yet despite the fact VicForests successfully appealed the original decision of Justice Mortimer, the Friends of Leadbeater's Possum continue to wage their unfair attack against Victoria's native forestry industry by appealing the recently handed down judgment.

In the meantime, industry is left with its hands tied, unable to supply the nation with timber which is in short supply. This puts the livelihoods of hard-working people at risk. Timber is a sustainable industry that is under an increasing threat from so-called 'environmental groups' who are not willing to examine the facts about its environmental credentials, including forest management.

The Nationals will pursue this Private Senators Bill to give certainty for our native forest industries and those who rely on it. It has the full backing of the CFMEU while Labor has turned its back on the workers it claims to represent.

### **NEW REPORT BACKS REGIONAL AUSTRALIA POST SERVICES**

Certainty of the future of Australia Post and its services has been secured for the licensees, employees and regional communities who rely on vital post services, following the recent tabling of the Australia Post inquiry report in Parliament. Nationals senators are backing changes that will enhance the viability and sustainability of Licensed Post Offices (LPOs).

viability and sustainability of Licensed Post Offices (LPOs).

They include:

- Guaranteeing financial stability for 2,500 post offices in the regions.
- No privatisation or divestiture of Australia Post and its services
- Ensure essential parcels and financial services remain and grow, as core business of Australia Post's community service obligations.

The focus of the inquiry extended beyond the events that led to former CEO Christine Holgate's exit from Australia Post, examining service delivery, temporary regulatory relief, and the Boston Consulting Group's review of the organisation, which canvassed privatisation options.

The Nationals will never support privatisation or divestiture of Australia Post or subsets of the business and all directors of the Australia Post supported this in evidence.

This is why, if necessary, we will move amendments to legislation to make certain that financial services are increased and the parcels service is classified as core business with performance regulations and community service obligations amended to reflect this.

Banking services, and the delivery of perishable foods following Australia Post's announcement they would cease delivering these goods, were explored by The Nationals throughout public hearings. Many agricultural and food businesses rely on Australia Post to deliver their food products so it was important Australia Post improves their consultation and works to address the regulatory challenges rather than cutting this service.

The Bank@Post deal has provided greater access to financial services for regional communities and financial security, opportunity and growth for LPOs who offer these services, but this comes at a cost to licensees. The deal is beneficial for the banks as well, so it is only fair that the costs for this service are paid for by the banks and Australia Post must seize opportunities to expand these offerings.

I have also previously written to the Chair of Australia Post to ensure that the number of LPOs in regional, rural and remote Australia will be maintained or increased, and included recommendations to this effect in the report.



#### **MY STANCE ON ZERO EMISSIONS**

There is no agreement with the second party of the Coalition government on any target date for zero emissions. I believe setting a specific date to reach net-zero emissions would fly in the face of the Nationals Party's public policy commitment.

Regional Australia is contributing to lowering emissions by exporting high calorific thermal coal.

Australia is in danger of sleepwalking into an international agreement which favours large, rich industrialised nuclear-powered nations, like members of the G7. We need reliable, secure and cheap power for everyday Aussies, business and industry.

#### AUSTRALIA-UK FREE TRADE DEAL SECURED

Australia and the UK have reached an agreement in principle on core elements of a free trade deal that strengths, expands and diversifies export opportunities for our producers especially during our COVID recovery and tensions with China.

In what's set to be Australia's most ambitious FTA with any country, other than New Zealand, it will see tariffs on Australian wine (including from our fabulous Victorian wine making regions), and rice eliminated as soon as the agreement enters into force.

Beef tariffs will be eliminated after ten years. During the transition period, Australia will have immediate access to a duty-free quota of 35,000 tonnes, rising in equal instalments to 110,000 tonnes in year 10. In the subsequent five years, a safeguard will apply on beef imports exceeding a further volume threshold rising in equal instalments to 175,000 tonnes, levying a tariff safeguard duty of 20 per cent for the rest of the calendar year. Sheep meat tariffs will be eliminated after ten years. During the transition

period, Australia will have immediate access to a duty-free quota of 25,000 tonnes, rising in equal instalments to 75,000 tonnes in year 10. In the subsequent five years a safeguard will apply on sheep meat imports exceeding a further volume threshold rising in equal instalments to 125,000 tonnes, levying a tariff safeguard duty of 20 per cent for the rest of the calendar year.

Dairy tariffs will be eliminated over five years. During the transition period, Australia will have immediate access to a duty-free quota for cheese of 24,000 tonnes, rising in equal instalments to 48,000 tonnes in year five. Australia will also have immediate access to a duty-free quota for non-cheese dairy of 20,000 tonnes.

UK consumers are set to again benefit from having Australia's high quality and safe agricultural products on their shelves and that is great news, as well as delivering business and job opportunities.
